

## **Chuuuuuuuuuuuuuuut, we are being genocidated and it's global**

In 2015, I met a Tunisian professor of economic intelligence, in the Lyon region.

We got to know each other on the internet.

An exchange on the history of Tunisia and various works related to economic intelligence among others.

This professor sent me a study following my questions on an article on international accounting standards.

It seems boring as a subject and I confirm it.

Besides, that's why it's boring, because the people should above all not understand the cornerstone of our murderous global financial system, put in place on the people and without their knowledge.

This is the global chart of accounts, or rather the double counting part, valid in all countries of the world.

Yes, the chart of accounts, who would have thought.

Thinking about it, it makes sense, the chart of accounts being the translation tool that allows you to translate your work, the people, into something called capital.

Globally, we are managed by a pyramid-like tree-structured chart of accounts, centralized at the top of the great balance sheet of humanity to one income statement.

Except that on closer inspection, this income statement is a debt account.

You do not believe me?

This is precisely the subject of a study of about 180 pages that I did following this study on international accounting standards transmitted by a Tunisian professor.

Thesis whose title is more than revealing: "Economic Genocide of Nations".

But the most surprising thing is that through a database management analysis, on the world balance sheet of humanity in double entry (assets/liabilities), we can demonstrate, and this mathematically, that the universal chart of accounts is a programming by encapsulation, to be able to manage a set.

From an accounting point of view, man being only a tool for the production of capital, he is therefore dependent on capital, capital managed worldwide by a minority of people who can be legally challenged for organized fraud.

We are therefore on a system of slavery and more genocidal.

This is the work I did in the thesis "Economic Genocide of Nations".

As long as the place of man in the chart of accounts will be the tool for exploiting capital, tell yourself one thing, mathematically, by database management, you are a debt.

No constitution in the whole world can do anything about it.

Which is to say that capitalism is the collectivization of data, wealth, property, to a debt account.

Communism is also collectivization, and in both cases, be it capitalism or communism, collectivization is managed by a minority.

Without doing politics, on both sides, it is the spoliation of property from the populations, except that capitalism has the same goal as communism, but for the first its goal is not immediately achieved.

Properties are collectivized in time to an illegal sovereign debt in the eyes of the law. It is therefore necessary that this debt be sufficient to justify the seizure of properties by debts revealing themselves to be a fraud and this legally by an analysis of the global financial arrangement.

The only solution is to change the place of man in the universal global chart of accounts. This is the primary ethic that all our leaders should have.

But be happy, this thesis has been sent to many senators and mayors, from deputies to regional and departmental advisers, and this since the end of 2020 on French soil.

Note that nothing transpires from our dear French elected officials.

The main news: the Covid. People have to be scared and distracted from the real problem. Covid, which you will notice with your Lynx eyes is coming at the right time on humanity.

This seriously suits our charming friends the oligarchs.

One stone kills two birds for them.

The people are terrorized by mass propaganda orchestrated by the media, some of which are held by the oligarchs, and this makes for magnificent diversionary propaganda for the peoples who forget the main point: "We are all in the midst of genocide and the everything legally provable", which in legal jargon is called a crime against humanity.
